- DIRECTIONS:** From I-77 take Hwy 421 North towards North Wilkesboro. Take NC Hwy 16N exit; in approx. 6.4 miles turn right onto Old NC Hwy 16. Approx. 3 miles turn right onto Vannoy Rd. After approx. 2.6 miles bear left onto Sheets Gap Rd. Follow arrows - field will be on left. **GPS Coordinates:** N 36° 17.412', W 081° 17.049'
- COURSE:** 40-50 miles of trails-all on private land. All start controls and good resets for all rider abilities. No pit riding!
- TECH INSPECTION:** On starting line - bike must have USFS approved spark arrester. No tags or headlights required.
- ENTRY FEE:** \$50.00
- REGISTRATION:** All pre-entries must be mailed by Friday, September 24 - **no row reservations by phone!**  
Row selection on 1st come, 1st served basis - no row swapping permitted.
