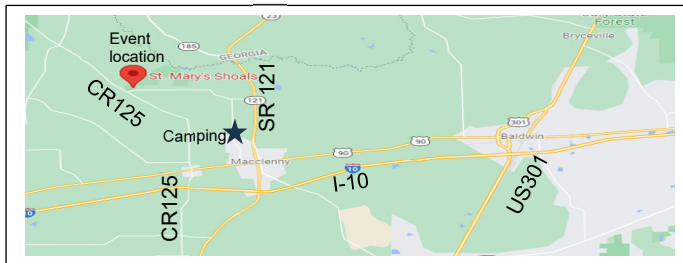

I have voluntarily entered an FTR/SETRA/AMA co-sanctioned event, the St. Mary's Shoals Enduro on November 19, 2023. An FTR/SETRA/AMA co-sanction indicates that this event is listed in the organization's official calendar. The officials for this event have not been trained or accredited by the FTR, SETRA or the AMA. Motor sports are dangerous.
